Enclosed you will find an order form for Crosstech Systems' new release (Release #2018.01) of the After-the-Fact Payroll (Windows 32-bit and 64-bit) Package. Our email address is info@crosstechsystems.net, please update your records. The package will include the updated format for 2017 year end on all forms previously printed. **Note: New features available:**

- Updated format for 2017 year end, on all forms previously printed, Year End and Quarterly Forms.
- New Deduction Code for Paid Family Leave along with new reporting for a given period for employees with this deduction.
- Magnetic Media Filing for IRS W-2 format - allows magnetic media filing of W-2's for multiple clients on one file for an internet upload. Requires a form to be filed with the IRS, for each client to be magnetic media approved.
- Visit our website www.crosstechsystems.net, and download technical updates and order forms directly from the web, select the downloads option or go directly to www.crosstechsystems.net/downloads, the technical updates will be posted as needed. Feel free to email us at info@crosstechsystems.net with any questions about the download procedures.
- The IRS is requiring all payments to be made by all depositors online or using their Batch Processing Application. **Revised Depository management and EFTPS export** routine for weekly, monthly and/or quarterly payments, for individual payroll depositor and/or group batch depositor payments. The reporting of payment due on 941, 940, and 944 forms will be managed by this new routine. The payroll management will store the payment information. This information can be reviewed in the payroll on the screen and/or printed (by period). Note this is optional and will have at an additional charge.
- Documentation (On-Line Help) in Windows enhanced format. Within the document will be a chapter of new features, to simplify this and future releases.
- Second withholding State for Income Tax. This requires State withholding update. Call for additional charges.
- To request additional specific enhancements, send an email to info@crosstechsystems.net. State the enhancement and give a contact name with phone number for any questions.

The release #2018.01 of the After-the-Fact Payroll requires the Business Rules 4.3x release. General Ledger Release #2018.01 is required for After-the-Fact Payroll to continue After-the-Fact Payroll Check entry in Cash Disbursements Journal.
